**CANCELLATION PENALTIES (All cancellations must be received in writing by the trip leader):**

**United Airlines Group Cancellation Policies-block space:** Seats may be cancelled in full or reduced with no penalties prior to November 19, 2020 as long as 10 seats are still utilized if holding block air space. 90% of all remaining seats held on November 19, 2020 must be utilized. Cancellations of over 10% of seats held on November 19, 2020 will result in \$175 penalty for each seat cancelled until November 19 2020 when tickets are issued. Tickets issued but not used will not count toward utilization. Complete name list with TSA information is due November 19, 2020. Reservations held after November 20, 2020 without names will be released and subject to full penalties. Name changes or itinerary changes made after ticketing will result in a \$250 fee, plus any difference in fare. ALL CHANGES MUST BE MADE 14 BUSINESS DAYS PRIOR TO FLIGHT DEPARTURE. Unused tickets are non-refundable. **Upgraded seats may not be available on group seats. If participants want to purchase upgraded seats they will need to purchase air separately from the group block and those seats will not count towards group air block numbers or comp credits.** Partially used tickets are nonrefundable and have no value. Discount certificates, vouchers, senior discount & any other promotional items cannot be used in conjunction with this fare. Full mileage credit is no longer accrued on all flights depending on fare and mileage status. A group consists of a minimum of 10 passengers traveling together on the same flights. If the group drops below 10 passengers on each or either block of seats, the group fare may no longer apply and tickets will need to be purchased at the current market rate. Applicable deposit money may be forfeited.
